#### METHODOLOGY

The oral history interview collections listed below were compiled from archives in the USA. To be relevant, collections had to contain oral history interviews pertaining to deindustrialization post-1960. I interpreted "deindustrialization" broadly to include the far-reaching and long-lasting impacts of industrial closures and restructuring. I looked for collections that focused on plant, factory, mine, or mill closures from the perspectives of workers, families of workers, management, or people in the community generally affected by the closures; on restructuring or automation in industrial environments (especially from the 1970s-1990s); on development or redevelopment of formerly-industrial sites or neighborhoods; on strikes and/or labor organizing that occurred in response to industrial closures or restructuring and on the impact of closures on unions; and on the environmental impacts of various industries that continued after the closure of those industries. I came across a great many oral history collections that focused on labour organizing, unions, and labour movements in many different states, but I made sure to only include collections in this inventory that made specific reference to deindustrialization as it is broadly interpreted here.

My method for finding these collections was to work through government, university, and private archives in one state at a time. I also searched the Library of Congress archives, though that search did not turn up relevant findings. After selecting a state, I first identified universities in that state that had oral history collections and then went through these archives individually to see if any collections met my search criteria. Generally, this took the form of looking through finding aids and doing keyword searches related to the above search criteria. If they existed, I looked through the oral history collections of State Archives, Historical Society Archives and Oral History Societies in each state. I also did general searches in each state for museums or private archives that might have an (post)industrial focus, i.e. "Labour Museum" or "Worker Museum" or "Industrial Heritage" + the name of the state, or for oral history archives in a particular state. These searches sometimes yielded institutions with relevant oral history collections. Once I had completed my search at a given archive, I contacted the archive by email to make sure I wasn't missing anything in their collection and to ask for recommendations on where I might find other deindustrialization-related oral history collections. This "snowball" inquiry method worked quite well, and I was introduced to several archives with relevant collections I would probably not have found otherwise. Finally, I checked the archives of public libraries in large cities in each state. These searches did not turn up any relevant collections, but they did sometimes provide connections to other archives

I would have missed.

It details the events of the 1937 sit-down strike at Guide Lamp and the various improvements in working conditions, wages, job security, and benefits that the United Auto Workers helped to influence at the two plants. The project highlights changes in policy towards women, minority groups, and retirees in the factory workplace, and it offers descriptions of the evolving roles of management and the union and changing relationships among workers in the two plants. DESCRIPTION	"In the early 1960s, the United Mine Workers Welfare and Retirement Fund canceled medical cards held by union miners who were working for companies that failed to pay their royalty fees to the fund. In a few eastern Kentucky counties, the miners responded by traveling from mine to mine closing them down. Known as the Roving Picket Movement, it evolved by 1964 into the Appalachian Committee for Full Employment, an antipoverty organization whose goal was to organize unemployed miners and make the local War on Poverty programs more responsive to poor people. The Roving Picket Movement eventually led to pressures for black lung legislation in the late 1960s and to the reform of the United Mine Workers of America through the creation of Miners for Democracy. Interviewees include management personnel, public officials, coal operators, and miners and their families. Topics not mentioned above include industrial development, the Kentucky River Coal Corporation, violence in the coal fields, the Unemployed Fathers Program (the "Happy Pappy" Program), communism, the Brookside mine, the Citizens Committee for Law and Order, the Hazard Herald, mechanization, mine safety, the 1959 strike, Harlan County, women pickets, the Battle of Evarts, John Blair, Charlie Combs, Berman Gibson, Arnold Miller, and Judge Courtney Wells."

"<u>The Wyoming Valley/Wilkes-Barre Oral History Project</u>: Interviews conducted after 1975 with a cross-section of community members who addressed topics such as mining, immigration, ethnicity, economic development, local history, government, women, garment manufacturing, family, religion, the arts, a major flood disaster, a major mining disaster, and sports. The interviews cover the period between the 1930s and the early 21st century."

2. "<u>The Laurel Run Mine Fire Oral History Project</u>: Interviews conducted in 1985 with former residents of the Laurel Run section of Wilkes—Barre Township, the scene of a still—burning underground mine fire. Topics represented include family, home, community, and forced relocation are highlighted. Owner of the collection: WVIA—FM (Public Radio in northern Pennsylvania)."

3. "<u>The Bear Creek and the Harvey's Lake Oral History Project</u>: Interviews conducted in the 1980s and 1990s with individuals involved with the lumber industry in the rural area of Bear Creek Township and Luzerne County.
