MESSAGE FROM THE PRINCIPAL INVESTIGATOR, STEVEN HIGH

Hello everyone,

It is hard to believe that we have now completed the third year of our seven-year project journey in DePOT.

This past year was another eventful one, ending in a fabulous series of in-person events in Sydney, Cape Breton organized by Lachlan Mackinnon. There were many highlights over those six days of meetings, which started with a two days creative writing workshop organized by the Fritz-Hüser-Institut, followed by the summer institute at the Glace Bay Miners' Museum organized by the Student Caucus, and ended with the culminating conference of the Politics of Industrial Closure Working Group where our first two Artists-in-Residence, Francesca Marconi (Italy) and Russell Gendron (Canada), showcased their inspiring research-creation in a conference plenary. The keynotes were given by Marion Fontaine and Magdalena Novoa.

A lot of great research came out of DePOT's Industrial Closure Working Group, the first of six WGs which are our primary research interventions. The Cape Breton conference saw the launch of a special themed issue of the independent trade union magazine *Our Times* (led by myself), a special issue of the labour studies journal *Labour/Le Travail* (led by Lachlan Mackinnon), and a special series of blogs on *Active History* edited by Lauren Laframboise. The Working Group is also producing a special issue of *Labor History* (co-edited by Marion Fontaine, Lauren Laframboise and myself), a special issue of the Portuguese journal *Industrial Archaeology* (co-edited by Maria Beatriz Andreotti and myself), the first edited volume in our new DEPOT book series at the University of Toronto Press, as well as three monographs. There is also two Routledge edited volumes nearing completion, one a *Handbook on Deindustrialization Studies* (lead editor Tim Strangleman) and the other on South Asia (lead editor Indranil Chakraborty). Other team members have also published books, articles, and graduate theses.

The Gender & Family Working Group, led by Jackie Clarke and Arthur McIvor, will be culminating in June 2024 in Glasgow/Belfast, and after that the Race, Populism and the Left WG in June 2025 in France. Their research is well underway. The Environment and Heritage Working Groups are also starting up – which means that there are four working groups underway this year, making this our peak year.

We also have committees hard-at-work on the deindustrial objects platform, which should be launched shortly, as well as our end-of-project exhibition. We also have an active monthly blog – a great opportunity to 'spin' your latest research for the wider public.

Huge thanks, as always, to the generosity of our team members and partners, including a number of new ones. Thanks, too, to Gabrielle McLaren for her excellent leadership.

MIDTERM UPDATE

This year, DePOT submitted its Midterm
Report to our funding agency, the Social
Sciences and Research Council of Canada.
The report's goal was to provide an overall
view of the partnership's accomplishments for
an expert committee to assess the project's
accomplishments, next steps, and future
directions. Project members can access the
final report on Basecamp.

Compiling the Midterm Report highlighted DePOT's growth in its first three years. The project has produced a wide range of scholarly publications as well as podcasts, blogs, op-eds, magazine articles, and artistic outcomes. Our virtual roundtables have attracted 1,092 attendees from around the world. While the pandemic forced us to modify our original plans for Years 1 and 2, including our first face-to-face meetings including our most recent project assembly in Sydney, Nova Scotia. Our research program is proceeding

apace within the thematic research initiative working groups.

We have forged a strong working relationship with our partner organizations, both university and non-university. Our project team now consists of 26 SSHRC-recognized co-researchers and collaborators, 48 formal partners, 45 affiliated graduate students (80% supervised by team members), 12 affiliated postdoctoral fellows, and 24 Research Associates. This strategic growth has deepened our capacity to study the six core countries and has enabled us to make wider geographic connections.

GOVERNANCE AND ETHICS

DePOT continues to be governed through a collective governance structure, anchored by our Coordinating Committee (see Appendix 1). Gabrielle McLaren remains DePOT's full-time project manager.

The project's Coordinating Committee – comprised of Steven High, Lucie Morisset, Lachlan Mackinnon, Gregory Wilson, Jackie Clarke, Arthur McIvor, Stefan Berger, Marion Fontaine, Stefan Moitra, Petra Dolota, and Thomas Wilson as student representative – continues to meet bimonthly. The Coordinating Committee approves new affiliations on an ongoing basis to expand the project, keeps a bird's eye view of the project's activities, and ensures that DePOT adapts to new developments while still fulfilling the goals and obligations originally established in our application.

Besides the Coordinating Committee, DePOT has four project-wide administrative committees responsible for (1) the artist-in-residency (AIR) programme (co-led by Jana Golombek and Petra Dolata), (2) the "Histories of Deindustrialization Through Objects" platform (led by Rebecca Dolgoy), (3) DePOT's Capstone Exhibition committee (Jana Golombek and Rebecca Dolgoy), and (4) the Editorial Board for our University of Toronto Press book series. There is also an active self-governing student and postdoc caucus.

DePOT retains full ethics approval from Concordia University, from which the project-wide ethics framework for oral history interviewing follows. As the funding comes from Canada, the entire project must follow Canada's <u>Tri-Council Policy on Research Ethics</u>. Project affiliates may access documents related to our ethics through Basecamp. In cases where there are no formal research ethics regimes (Italy, France, Germany) or where oral history is exempted from institutional review (United States), DePOT members use the Concordia model.

The thematic working groups, where the bulk of research is undertaken, are each co-led by two co-investigators. Our annual Project Assembly offers a space of project-wide reflection.

STUDENT & POSTDOC CAUCUS REPORT

The caucus is the student division of the DePOT project, incorporating all students and postdocs who are affiliated with DePOT. Currently, we meet on Zoom once a month.

The caucus aims to provide an informal and friendly space for student and postdoctoral affiliates of the project to discuss ideas, get to know one another and keep in touch, share knowledge and advice. Our priority for the monthly meetings is for it to feel like a welcoming

space where everyone has a voice and can feel part of an international research community. The content of these meetings is flexible. However, we aim to provide both opportunities for catching up and getting to know new members, and informative and troubleshooting sessions where members can share their experiences and offer advice. For example, we are preparing sessions on topics like funding, applying for post-doctoral projects, and the postdoctoral experience.

The steering committee is a division of the student caucus responsible for organising meetings and overseeing the caucus' aims. The steering committee is currently composed of Naomi Petropoulos, Rebekah Chatellier, Sinead Burns, Shonagh Joice and Katherine Watson. The steering committee is always open to new members and ideas and there is no formal process or election to join.

KNOWLEDGE MOBILIZATION

Thanks to DePOT's array of knowledge dissemination strategies, we have reached most of the knowledge mobilization goals that we had outlined in our SSHRC Milestone Report, putting us on track to reach our project's overall goals. We share our research activities through our website (developed by Mat3rial and now available in all four project languages), our X (Twitter) account (1,149 followers), and newsletter (395 subscribers).

The students who have worked as Communications Coordinator are largely responsible for DePOT's increased and diversified digital presence: Shaina Willison, Graham Latham, Connor Kilroy, and Amélie Pelletier.

PODCASTING AND MULTIMEDIA CONTENT

The DePOT podcast, initiated by the Student and Postdoc Caucus, has continued to grow.

(Concordia University), and Amber Ward (University of St. Andrews) who stopped by Montreal while a visiting student at the University of Berkeley. Using the 2000 film *Billy Elliot* as a starting point, the speakers discussed the value of gender and queerness in stories of deindustrialization. A live audience at 4th SPACE and viewers on Zoom and YouTube were able to follow the conversation and ask questions.

As longtime host Amanda Whitt finalizes their MA thesis, Fred Burrill and William Gillies (Concordia University) have taken over the podcast's production and publishing as French and English-language hosts specifically. Their first episode, published in October, recapped the annual conference that took place in Sydney, Nova Scotia.

Aside from the DePOT podcast, DePOT affiliates are also sharing their research on feeds like *The Outrageous History* podcast (Dimitry Anastakis), *CBC What On Earth* (Petra Dolata), *The Historian's Cut* podcast (Pete Hodson), and *Talking Derry Girls* (a podcast recapping *The Derry Girls* where Naomi Petropoulos shared her research).

DePOT team members have also contributed to various documentary films and series. Théo Georget participated in a documentary on the deindustrialization of Lorraine that drew on French novelist Nicolas Mathieu's *Leurs enfants après eux*. Fred Burrill was interviewed as an activist and historian for his work on deindustrialization and gentrification as part of *The Green Divide: Struggles for Environmental Justice in Europe and North America*, an interactive online documentary produced by the Barcelona Laboratory for Urban Environmental Sustainability that allows users to compare "the impact of greening and redevelopment plans on working-class neighbourhoods in six cities in Europe and North America." Lucie Morisset was behind the scriptwriting, editing, and video production of "Conserver les maisons d'Arvida," released by the Canada Research Chair in Urban Heritage. Andy Clark also contributed to *Sitting Tight: The Story of the Lee Jeans Sit-In*, one of the case studies featured in his book *Fighting Deindustrialization: Scottish Womens Factory Occupations*, 1981-1982 (2022).

PUBLIC PROGRAMMING

As a public-facing project dedicated to enriching public discourse on deindustrialization, DePOT and its members have been involved in a variety of public lectures, roundtables, and workshops (see Appendix 4 for a complete list).

2022-2023 ROUNDTABLE SERIES

The DePOT project organized 6 online roundtables in the past year. Each roundtable brought 6-8 people with a range of regional and thematic expertise to speak on a theme. Since the launch of <u>our YouTube channel</u> these roundtables remain accessible and can be revisited and rewatched; the channel has garnered 2,435 views, with the roundtable on Deindustrializating Eastern Europe garnering the most views (290).

Our first Fall roundtable on <u>nostalgia</u> emerged following a Twitter exchange between DePOT researchers Hilary Orange (Swansea University) and Andy Clark (Newcastle University), highlighting the value of DePOT's digital network. The roundtable brought together Andy Clark, Fred Burrill (Cape Breton University), Jackie Clarke (University of Glasgow), Sinead Burns (Queen's University Belfast), Stefan Berger (Ruhr-Universität Bochum), Magdalena

Novoa (University of Ilinois Urbana-Champaign), and Ewan Gibbs (University of Glasgow) to discuss nostalgia's use as a methodological tool to analyze experiences of deindustrialization.

"Where did all the jobs go?" was DePOT's first hybrid roundtable, organized in collaboration with the Calgary Institute for the Humanities. Petra Dolota and Anna Bettini (University of Calgary) were joined by Lauren Laframboise (Concordia University), Fred Burrill, and Lachlan MacKinnon (Cape Breton University) who had traveled to Calgary for the Canadian Committee on Labour History conference. In a discussion moderated by Jim Ellis (director of the Calgary Institute for the Humanities), presenters drew on working-class communities' experiences with resource extractive industries to discuss what lessons may be applicable in a continuingly deindustrialization world.

Newer affiliates of the DePOT program shared

their research during the "New Approaches to Deindustrialization Studies" roundtable on December 6, 2022. Lisa Taylor (Leeds Beckett University), Maria Beatriz Andreotti (University of São Paulo), Michael Bianchi (Université de Liège), Peter Thompson (Carleton University), Sahar Ghasemshani (Université du Québec à Montréal), and Seana Irvine (Trent University) spoke on a broad range of research topics from reclaiming slag banks to autoethnographies of fatherlessness to the intersection of settler colonialism, industry, and environmental pollution. Sean O'Connell (Queen's University Belfast) moderated the event and facilitated a question-and-answer period.

January 2023 began with the "Deindustrializing Eastern Europe" roundtable organized by Stefan Berger and Juliane Tomann (Center for Commemorative Culture at Regensburg University). They were joined by Magdalena Rek-Woźniak (University of Łódź), Joanna Wawrzyniak (University of Warsaw's Social Memory Laboratory), Györgyi Nemeth (retired associate professor from the University of Miskolc, Hungary), Tibor Valuch (Centre for Social Sciences Institute of Political Science, Budapest, and Institute of History Eszterházy Károly Catholic University, Eger), Andrea Pokludová (University of Ostrava), and Ulf Brammer (Leibniz Institute for East and Southeast European Studies in Regensburg). The speakers gave presentations on industrial heritage and oral history projects across Poland, Hungary, and the Czech Republic. The roundtable finished with a transnational presentation by Ulf Brunnbauer about shipbuilding after Communism across Eastern Europe, and a question-

and-answer period that highlighted the complexity of industrial heritage and cosmopolitization.

<u>"Energy Transitions and Deindustrialization,"</u> featured six speakers who drew on global energy history to discuss past energy transitions—involving biomass, coal, steam, and oil—and how future energy transitions should be handled for the health of communities, workers, and the planet. The lineup included the two new Fulbright Canada Research Chairs in Energy Transitions and Deindustrialization, Jeff Manuel and Chad Montrie, who were joined by Anna Bettini (University of Calgary), Amber Ward (University of St Andrews), Petra Dolata (University of Calgary), Robert Suits (University of Edinburgh), and William Gillies (Concordia University). The roundtable, moderated by Greg Wilson, drew audience members from outside the project who testified to this roundtable's thematic resonance.

Finally, Indranil Chakraborty (Horizon Postdoctoral Fellow at Concordia University) organized a roundtable dedicated to South Asia: "Deindustrialization and Reindustrialization in South Asia: Enclaves of Inequality, Precarity, and Prosperity." Dr Anirban Acharya (Le Moyne College, USA), Dr Sudho Basu (McGill University, Canada), Azizur Russel (McGill University), Sartaj Khan (independent researcher, based in Pakistan), Dr Atreyee Majumdar (National Law School of India University), and Dr Dipak Gyawali (Social Sciences Baha, Nepal). Interventions on Pakistan, Nepal, and India drew attendees' attention to how deindustrialization manifests itself and looks in the Global South.

ARTIST-IN-RESIDENCE PROGRAM

DePOT's Artist-in-Residence program aims to foster creative projects and interventions in the field of deindustrialization studies. Through the program, two grassroots artists per research initiative receive \$8,000 CAD in funding to create and share new work locally and transnationally. This year, the DePOT community met its first two artists-in-residence and is looking forwards to meeting two new artists at our next conference. Thank you to the Artist in Residence committee co-chairs Petra Dolota and Jana Golombek, as well as the other

members of the adjudication committee: Emily Gann, Juliette Passilly, and Lisa Taylor.

OUTGOING ARTISTS-IN-RESIDENCE: RUSSELL GENDRON AND FRANCESCA MARCONI

Francesca Marconi (Milan, Italy) and Russell Gendron (Montreal and Vancouver, Canada) joined us in Cape Breton for a special Artist-in-Residence plenary to showcase their work on the Politics of Industrial Closure.

Russell played clips from a soundscape entitled "The Mill," which blended oral history interviews with recordings from a working sawmill, rural British Columbia, and his own family's home. The immersive soundscape that spoke to the uncertainty, camaraderie, and atmosphere of the lumber community where he grew up.

Francesca then shared collage images she had made from archival images drawn from the Fondazione ISEC's (Instituto per la storia dell'età contemporanea) archive. The final zine in which these images are showcased, *Manifesto el Presente*, merged the stories of precarious workers

with materials that workers had chosen from Francesca's archival selection.

INCOMING ARISTS-IN-RESIDENCE

JENNIFER VANDERPOOL, U.S.A.



Jennifer Vanderpool is a multidisciplinary artist, curator, and writer based in Los Angeles, California, United States. A native of the Mahoning Valley in Northeast Ohio, she draws on her immigrant Ukrainian family's stories about working in sweatshops and factories as a lens to question the social construction of place based on the influences of history, race, class, gender, and labor. She explores workers' lives and cities through community-specific and site-responsive projects.

City Beautiful is a publicly accessible community-specific and site-responsive social practice art project. It consists of three interconnected mediums. The first is an app creating an augmented reality digital mapping of Youngstown. Users can stop on their remote or in-

person exploration, select a site to see the once mighty mills or splendor of the grand main streets and neighborhoods, and then witness the deterioration of the site, too often into an abandoned lot with encroaching woodlands. Users may engage with commentary by locals, activists, urban planners, scholars, etc., about the citizenry's history, current predicament, and future possibilities, as well as a new generation of interactive VR artwork that users can access on their personal devices, portraying an imaginary post-prosperity city crafted from select imagery of industrial sites, downtowns, and neighborhoods. Jennifer chose these locales by following the migration of her Ukrainian grandparents, who were settled in the former mining town of Punxsutawney and followed short-term work to now disinvested cities before moving to Youngstown in 1967.

JILL MCKNIGHT, U.K.



Jill McKnight (b. 1990, Sunderland, UK) is a multidisciplinary artist working across sculpture, drawing, film, sound and writing. Her practice focuses on exploring lesser heard stories, particularly from women and working-class people. Recent work has looked at the representation of community identities and collective voices, together with more personal histories, capturing the multiplicity and commonality that exists within them. In 2021-22, McKnight was artist-in-residence for Collections in Dialogue, a co-commission between Leeds Art Gallery and the British Library, culminating in the artist's first institutional solo exhibition Desire Lines at Leeds Art Gallery. McKnight has previously exhibited at institutions across the UK, including The Art House, Wakefield; Saatchi Gallery; South

London Gallery; Wysing Arts Centre and Yorkshire Sculpture Park. McKnight was awarded a Henry Moore Foundation Artist Award in 2020.

Past and Future Pact will connect with residents of Sunderland, UK, to explore the identities of individuals in relation to the city where they live, more than 30 years since heavy industry closures. Jill will work with community participants and members of her own family to record perspectives of differently marginalised gendered experiences of care and domestic work in the family home and paid employment. In Stage 1 of the residency, she will arrange and record interviews, alongside making separate creative responses of writing, drawing and film. In Stage 2, Jill will develop, make and share a new body of work, including a soundscape, film, sculpture and digital sketchbook.

PUBLIC-FACING WRITING

DePOT's blog, nested on our website, has been publishing monthly throughout 2023 featuring work by student, partner, and faculty affiliates. The topics have ranged across thematic and geographical lines, with posts on Canada (such as <u>Jacques Desmarais's post</u>

on the Centre d'histoire et d'archive du travail's comparative work on six towns in Québec), Chile (don't miss Gabriela Julio Medel and Lorenzo Feltrin's post on noxious deindustrialization to mark the 50th anniversary of the military coup), Sweden (such as Stefan Backius's post comparing two regions in the country), and Wales (see Katherine Watson's post on May Day tourism).

Beyond the DePOT blog, our affiliates are also sharing their work on the Labour in Mining Blog (Henry), the Deutsches Bergbau-Museum Bochum and Montanhistorisches Dokumentationszentrum (Moitra), The Otter (Montrie), and various other institutional and university department blogs.

Notably, ahead of the Politics of Industrial Closure conference Lauren Laframboise guest-edited a series of blog posts on The Politics of Deindustrialization in Canada, which included entries by Liam Devitt, Nicholas Fast, Eliot Perrin, Anna Bettini, Peter Thompson, and a closing blog post by Steven High.

LIFE-WRITING WORKSHOP

Ahead of the conference, the Fritz Hüser Institute for Literary and Cultural Work Studies (FHI) organized a transnational workshop on the topic of "Life Writing and Deindustrialization" from June 19-20, 2023.

SUMMER INSTITUTE

DePOT student and postdoctoral affiliates gathered in Glace Bay, Nova Scotia at the Cape Breton Miners Museum for the Summer Institute (June 21-22). The Museum, <u>as its website</u> reads, "pays tribute to the region's long and rich history of coal mining [and] is home to profound stories of miners and their families."

The Summer Institute began with a "Welcome to Nova Scotia" roundtable, moderated by Fred Burrill (Cape Breton University), to help situate participants

In between panel presentations, participants were also able to tour the Miners Museum, explore the recreated historical Miner's Village, enjoy the Museum's grounds and ocean view, and take a tour of an underground coal mine led by two former coal miners. 2023 ANNUAL CONFERENCE: THE POLITICS OF INDUSTRIAL CLOSURE

DePOT's 2023 Annual Conference kicked off on June 22 with an informal walking tour of the former Sydney Steel Mill site, which has since been cleaned up and reopened to the public as Open Hearth Park, led by Lachlan MacKinnon and his uncle-in-law Gerry McCarron a former steel worker at SYSCO.

Attendees had time to explore Sydney before reconvening at the Old Sydney Society for the Annual J.B. McLachlan Memorial Lecture. This annual public lecture sets out to honour the life and legacy of J.B. McLachlan, one of Canada's most militant labour leaders who was instrumental in bringing collective bargaining to Cape Breton's coal mining industry during the First World War. Lachlan MacKinnon delivered this year's lecture, "'Cape Breton Bolshevism': The Workers' Movement from J.B. McLachlan to the 1981 Strike in Coal." This was the first J.B. McLachlan lecture held in person since the COVID-19 pandemic and was standing room only.

On June 23, conference attendees were greeted by a bagpipe player at Cape Breton University ahead of Marion Fontaine's opening keynote "The Un-Making of the French Working Class: Nation and History of Deindustrialization."

The conference featured 14 panels, workshops, and roundtables that showcased work from the upcoming edited collection *The Politics of Industrial Closure* in addition to other exciting new deindustrialization studies research or interrogations of key DePOT concepts such as the "Demystifying Transnational Approaches" roundtable. We also held DePOT's first Artist-in-Residence plenary.

The evening was celebratory: it began with a book launch highlighting team members' publications over the last year, followed by a reception and surprise concert by the Men of the **Deeps**: a choir of former coal miners from Cape Breton, formed in 1967. Team members regrouped at CBU the following day for Magdalena Novoa's keynote "We were replaced by pines': Dispossession, displacement, and the colonial wound in Pilpilco's coal plant closure" and the second half of the program.

Next year's conference "Gender, Family, and Deindustrialization" will be held in Glasgow, from June 25-26, 2024.

RESEARCH INITIATIVE REPORT: THE POLITICS OF INDUSTRIAL CLOSURE (2020-2023)

Many of the research outcomes of this working-group, which culminated in the June 2023 conference in Cape Breton, were mentioned in the PI report at the beginning of the Annual Report. Major outputs include a forthcoming edited volume with the University of Toronto Press and three special issues of scholarly journals: Labour/le Travail (lead: Lachlan Mackinnon), Arqueologia Industrial (lead: Maria Beatriz Andreotti), and Labor History (Marion Fontaine, Steven High and Lauren Laframboise). All the chapters in the edited volume are collaboratively written – a testament to our commitment to transnationalizing this field of research. There was also a special issue of Our Times, Canada's Independent Labour Magazine, and a blog series on Active History, edited by Lauren Laframboise. Among other publications, there are three monographs-in-the-making that directly originate in our working group authored by Indranil Chakraborty, Steven High, and Dimitry Anastaskis.

As the first of DePOT's six working groups to get underway, we had to deal with the pandemic – which forced us to adjust our initial plans. We therefore undertook targeted newspaper and archival research, available to all project members in our shared Sharepoint Research Commons (if you have not visited it, you should) as well as archival inventories of existing oral history interviews in the UK and US. These resources are designed to support the work of all DePOT members.

Our partner, the Centre d'histoire et d'archives du travail (CHAT), led by Jacques Desmarais, undertook extensive original research on deindustrializing Quebec cities, as well as selected interviews, and drafted a report on three cities. A fourth city, the iron mining town of Schefferville, was studied by Steven High and resulted in an article in the *Canadian Historical Review*. High's 2022 monograph *Deindustrializing Montreal*, won all three of the big book awards in Quebec History. Laframboise's article on Montreal's clothing industry in *Labour/le Travail* won the Standout Graduate Research Award for best research publication at Concordia.

In addition, Dimitry Anastakis worked closely with Emily Gann at Ingenium on an interview and exhibition project on the closing of the Oshawa GM plant. The research notes of four students involved are <u>available on our blog</u>. Several MA and PhD theses, tied to this working group, are also nearing completion.





HISTORIES OF DEINDUSTRIALIZATION THROUGH OBJECTS WEB PROJECT

Histories of Deindustrialization Through Objects is a digital project that gathers "objects" embodying experiences of deindustrialization to be displayed on a web platform developed by Mat3rial and housed on the DePOT website.

This year, the web project's curatorial committee has concentrated on simplifying the submission process for users and collecting feedback from DePOT's community. Thanks to an Experiential Learning grant from Concordia University, we were able to hire a student from Concordia's public history program, Scott Guy, to assist with German translations, consider user experience with fresh eyes, and develop activity worksheets to accompany the site.

The website will collect photographs of objects that speak to deindustrialization, submitted by researchers, oral history interviewees, project partners, students, community groups, and individuals. Submitters are asked to fill in basic mandatory fields that allow the website's users to search for objects based on geographical

region, relevant industry, and other criteria. Users can then build virtual collections. In this way, the project aims to offer interface for public engagement with DePOT and integrate material culture to complement, ground, and illuminate the oral histories and other research gathered by DePOT researchers, while also serving as a pedagogical and co-creation tool for students and communities.

QUEER HISTORIES OF INDUSTRIAL WORK: A DEPOT AND INGENIUM COLLABORATION

DePOT and Ingenium (the umbrella organization that maintains and interprets Canada's national collections for Science and Innovation and one of DePOT's partner organizations), are partnering to facilitate a 5-year paid research initiative to incorporate queer history and theory into deindustrialization studies.

The initiative was inspired by Liam Devitt's (Concordia University) methodological intervention on the presumed straightness of industrial and thus deindustrial spaces and

histories at the 2022 Summer Institute, entitled: "'Dad, why are we at a gay steel mill? Notes towards a queer study of deindustrialization." Devitt has been hired as the first contract researcher for Queer Histories of Industrial Work.

STUDENT-DIRECTED INITIATIVES

Since Fall 2020, when the Coordinating Committee made strategic shifts to DePOT's activities in light of the COVID-19 pandemic, students have been able to apply for periodic funding for Student-Directed Initiatives.

In Fall 2022, the following students received funding for their research activities and project creation:

ÈLIA CASALS-ALSINA AND JULIETTE PASSILLY, towards the development of their project "In giro: industrial heritage in dialog with the arts," which will examine the use of industrial heritage site within the world of art in France, Italy, Germany, and Spain – \$985

LIAM DEVITT, for travel funding to conduct oral history interviews related to their MA research on queer experiences and reactions to deindustrialization in Cape Breton, Nova Scotia. – \$1,500

MARIA BEATRIZ ANDREOTTI, INDRANIL CHAKRABORTY, AND ELIOT PERRIN, for travel funding to Batatuba (Brazil), Batanagar (India), and Ontario to conduct oral history interviews

and archival research on the closure of three Bata Shoe Company company towns. – \$3.000

TIM LIEBREGT, for travel funding to conduct archival research at the University of Windsor and Windsor Public Library about the United Auto Worker plants in the region, towards his MA thesis on the internal dynamics of Canadian unions in the 1980s. – \$985

LAUREN LAFRAMBOISE, to conduct oral history interviews with former organizers at the Immigrant Workers Centre and produce a public radio program on the closure of Montreal-based garment manufacturer Lamour (2007) in partnership with IWC community board member Stefan Christoff. – \$985

The first four episodes of "Voices at the Immigrant Workers Centre on Deindustrialization and Dissent in Montreal's Garment District" are now available on Soundcloud and DePOT's website, featuring interviews with four organizers, volunteers, and activists involved with the Immigrant Workers Centre. More information about the 2007 Lamour strike is available on the radio program's webpage.



BUDGETS & FINANCES

DePOT has continued to spend wisely within the project's budget envelopes, following the budget established by the Coordinating Committee in November 2020.

As part of the Midterm Report, DePOT compiled and reported the project's expenses for the first three years of the project, in addition to our projected expenses for the next four years, which informs this section of the annual report.

We are also pleased that the host institution (Concordia University) and partner organizations are meeting their overall financial commitments to the project, so far amounting to \$1,315,929 of cash and in-kind contributions to match funds awarded by SSHRC.

UNDERSTANDING THE TABLES BELOW

The tables below show the actual expenses from the first three years of the project and the projected expenses for the next 4 years of the project, as reported to SSHRC.

The budget categories are those used by SSHRC, repeated here for consistency and ease of reporting. As in past years, DePOT's main expenses have been student and postdoc funding, in addition to the full-time project director's salary (see: "Non-student salaries and benefits/stipends—Other" category). Also note that the "Professional/Technical Services" category, which has seen significant jumps, is largely related to translation services, web development, and the artist-in-residence program.

Note that these tables only denote the use of funds from DePOT's SSHRC Partnership Grant.

The table does not reflect or include the funds contributed by DePOT's partners (such as the generous funding of DePOT's Ruhr Valley partners who made the 2022 project assembly possible) or additional funding received by the project, including: Canada Summer Jobs Program wage subsidies for student workers, a Canadian Foundation for Innovation grant, and the SSHRC Insight grant that funded the 2023 Cape Breton Conference. This is especially noteworthy as far as student fellowships are concerned, as half of fellowships are paid through DePOT SSHRC funds, with the other half coming from the receiving student's home institution).


