MESSAGE FROM THE PRINCIPAL INVESTIGATOR, STEVEN HIGH

THE YEAR IN REVIEW

It has been another good year for the DePOT project. We are now half way through our eight-year journey. The SSHRC assessors were glowing in their praise for our project during their midterm review.

Our project team continues to grow with the addition of postdoctoral fellows, graduate students and research associates. Also, Sherry Lee Linkon joined us as a full co-researcher, bolstering our US team. A number of areas outside our core six country study area have also been developed further, enabling us to make wider connections to other parts of the world, especially Eastern Europe, Chile, Brazil, India, and China. The past year also saw the retirement of Tim Strangleman (thanks for everything Tim!), as a result Sherry is the new co-leader of the upcoming Working-Class Expressions working group.

Our June 2024 conference on the political economy of deindustrialization held in Cape Breton was a big success thanks to Lachlan Mackinnon and his team. More than 80 people made the trek to Canada's East Coast. One of the most impressive aspects of that conference was that so many of the papers were collaboratively written and crossed borders.

Even more people participated in our June 2025 conference on gendering deindustrialization studies held in Glasgow, organized by a team of people led by Jackie Clarke and Arthur McIvor. There were three concurrent sessions instead of the usual two – making it the largest conference to date. It was a milestone in the field. The 2024 Summer Institute for emerging scholars held at Queen's University Belfast was probably the most successful to date. Congratulations and thanks to the organizers!

The project's student caucus has been one of the project's highlights since the beginning. The project has continued to prioritize student-led initiatives thanks, in part, to funding from the RVR, which also contributed to our publication grants.

The past year has seen us ramp up our research with five of the project's six working-groups underway. One of these, on Industrial Closure, culminated at our 2024 conference in Cape Breton with special issues of *Labor History*, *Labour/le travail*, and *Our Times* as well as an edited volume – *The Politics of Industrial Closure: Transnational Patterns and Cross-National Comparisons* – which is undergoing peer review as I write. The environment, heritage and race working groups are deep into the research phase with the gender working group pivoting to the next collective volume.

Other effort to make wider global connections can be seen in project round-tables and publications. Four publications are now out or forthcoming:

 A special issue of the Portuguese-language journal *Industrial Archaeology*, led by Maria Beatriz Andreotti (who defended her PhD this past year), saw the publication of papers on Portugal, Brazil and Italy. It is the first non-English language collective publication coming out of the project.

- An edited volume on India, entitled *Deindustrialization and Economic Restructuring in Post-Reform India*, led by Indranil Chakraborty (who completed his postdoc at Concordia this past year) is now forthcoming with Routledge. Peer reviewers called the essays a "seminal" contribution.
- The Routledge International Handbook on Deindustrialization Studies, co-edited by Tim Strangleman, Sherry Lee Linkon, Jackie Clarke, Stefan Berger and myself, is now forthcoming as well.
- DePOT published an annotated bibliography on the deindustrialization scholarship on Africa prepared by Mauton Avoseh, a Concordia graduate student from Nigeria.

There are many other achievements. The *Deindustrial Objects* website has now been launched, thanks to the work of our museum partners Ingenium and the German Miners Museum. And the curatorial team, led by Jana Golombek and Rebecca Dolgoy, have come up with a compelling vision for our transnational exhibition in year 8. A new teaching committee, under the leadership of Hilary Orange and Sherry Lee Linkon, has also taken flight – adding an important dimension to our work. DePOT's artists-in-residence program has also been quite inspiring, thanks to the leadership of Petra Dolata and Jana.

Huge thanks go out to Gabrielle McLaren who leaves us to start her PhD. She did a fantastic job as our primary staffer as did Sophia Richter as postproduction coordinator. And a big welcome to Liam Devitt (who needs no introduction for most of us as they have been an active student affiliate in the project)!

A number of our student and postdoctoral affiliates are now graduating and several have recently landed tenure-track jobs. Congratulations to Marion Henry (Sorbonne), Fred Burrill (New Brunswick), Andy Clark (Stirling), Piyusha Chatterjee (Memorial), and Laurent Dambre-Sauvage (Rimouski)!

I am very much looking forward to our next conference in Paris in June 2025.

FAST FACTS AND WORKING GROUP REPORTS

GOVERNANCE AND ETHICS

DePOT continues to be governed through a collective governance structure, anchored by our Coordinating Committee (see Appendix 1). Gabrielle McLaren stepped down as DePOT's full-time project manager to pursue a PhD program, and was replaced by Liam Devitt, a long-time DePOT student affiliate who has recently defended their MA thesis at Concordia University's Department of History.

The project's Coordinating Committee continues to meet bimonthly to approve new affiliations on an ongoing basis to expand the project, keeps a bird's eye view of the project's activities, and ensures that DePOT adapts to new developments while still fulfilling the goals and obligations originally established in our application.

Besides the Coordinating Committee, DePOT has four project-wide administrative committees responsible for (1) the artist-in-residency (AIR) programme (co-led by Jana Golombek and Petra Dolata), (2) the "Histories of Deindustrialization Through Objects" platform (led by Rebecca Dolgoy), (3) DePOT's Capstone Exhibition committee (Jana Golombek and Rebecca Dolgoy), and (4) the Editorial Board for our University of Toronto Press book series. There is also an active self-governing student and postdoc caucus.

DePOT retains full ethics approval from Concordia University, from which the project-wide ethics framework for oral history interviewing follows. As the funding comes from Canada, the entire project must follow Canada's Tri-Council Policy on Research Ethics. Project affiliates may access documents related to our ethics through Basecamp. In cases where there are no formal research ethics regimes (Italy, France, Germany) or where oral history is exempted from institutional review (United States), DePOT members use the Concordia model.

The thematic working groups, where the bulk of research is undertaken, are each co-led by two co-investigators. Our annual Project Assembly offers a space of project-wide reflection.

STUDENT & POSTDOC CAUCUS REPORT

Over the past year, the student caucus implemented several changes aimed at improving engagement and fostering a more inclusive and supportive environment. One of the key shifts was in the way sessions were organized, with the introduction of Outlook calendar invites and meeting agendas to ensure participants were well-informed ahead of time. This structure helped members know in advance what topics would be covered and contributed to better preparation.

A major focus was on adopting a more person-centered approach, emphasizing the importance of connecting on a personal level. Sessions included discussions such as "win of the month," where members shared personal achievements, tips, and advice to support each other. Additionally, members were invited to host sessions based on their own specializations or current projects, which helped foster a sense of ownership and relevance.

Ice-breakers were also introduced to warm up the group and create a more relaxed atmosphere.

The caucus actively sought feedback from members, polling them to shape session topics. This led to a broader range of discussions, not just about research, but also about life as a student or postdoc. Sessions covered topics like life after a PhD and the meaning of being a PhD student. While there were still research-based discussions, the emphasis shifted to addressing the holistic experience of being an early-career researcher. Looking ahead, we hope to build on this foundation and continue the work the previous caucus implemented. Our goal for the coming year is to increase participation by maintaining the person-centered approach and enhancing engagement through tailored sessions and interactive

POLITICS OF INDUSTRIAL CLOSURE

The Industrial Closure Working Group wrapped up its work this past year. Over three and a half years we published two special issues of journals (*Labor History, Labour/le Travail*), a special issue of an independent trade union magazine (*Our Times*), a six-part series of opeds published by a major newspaper (*La Presse*), a forthcoming edited volume focused on India (Routledge), and the main edited volume is now under peer review with the University of Toronto Press. All essays in the culminating volume are collaboratively written and cross borders giving it a strong identity and contribution. One monograph, which was a direct result of the working group, will be published by Between the Lines Press in February 2025 with several others are in process. Several student members of the working-group have also completed their MA and PhD theses with others are nearing completion. A large number of other scholarly and public outcomes have also resulted, including the work of our two associated Artists-in-Residence, whose work continues to live on in a variety of ways. - Steven High and Stefan Berger, Industrial Closure co-leaders.

GENDER, FAMILY, AND DEINDUSTRIALIZATION

This year the key outcome from the gender initiative has been a highly successful annual project assembly and conference in Glasgow, which has in turn allowed us to move forward with plans for our edited volume. This was the first major international conference on gender and deindustrialization and we welcomed over 100 delegates, including participants from France, Germany, Italy, Russia, US, Canada, Brazil, Chile and India, as well as the UK. An organizing committee composed of the gender theme leads (Clarke and McIvor), post-doc (Chatterjee), graduate student member (Chatellier) and local affiliate (McFadden) took care of the event planning and programming supported centrally by DePOT Associate Director, Gabrielle McLaren. The team raised funds from Glasgow City Council, Past & Present, Social History Society, Society for the Study of Labour History to support the event, notably providing bursaries to promote the participation of graduate students and other emerging scholars.

The conference made a significant contribution to DePOT's mission to connect deindustrialization scholars around the world, attracting a large number of proposals from outside the existing network and prompting a number of new affiliation applications. These connections also feed into plans for our edited volume, as conference delegates had the opportunity to propose a chapter for inclusion. Most draft chapters for the volume have now been submitted and are being considered by the editors. The volume will build on a coauthored historiographical essay, funded by DePOT and published in April 2024 with open access in International Labor and Working-Class history.

The DePOT funded post-doc, held by Dr Piyusha Chatterjee, has been another core activity of the gender initiative this year. Dr Chatterjee has contributed a chapter to the forthcoming Routledge International Handbook of Deindustrialization Studies and organised a film screening and interdisciplinary roundtable at the Centre for Contemporary Art in Glasgow on transnational solidarities and the garment supply chain, as well contributing significantly to the annual conference. The dedicated research time provided by SSHRC funding has also allowed Dr Chatterjee to leverage further funding in the form of a Leverhulme Early Career Fellowship. As Professor Arthur McIvor has recently stepped down as co-lead of the gender initiative, the planned edited volume will be taken forward with Dr Jackie Clarke and Dr Piyusha Chatterjee as co-editors, reinforcing the collaborative networks and opportunities for emerging scholars that DePOT has created.

THE RACE, POPULISM & THE LEFT WORKING GROUP

The Race, Populism & the Left Working Group, led by Steven High and Marion Fontaine, is focused on three interlocking themes. How strong is the link between right-wing populism and the deindustrialized working-class? How can we bridge the study of race and class in deindustrialization studies? Is the "failure of the left" thesis, which suggests that the failure of social democratic parties to effectively respond to the industrial crisis opened the door to right-wing populism, accurate?

Our Working Group brings together 24 researchers and 3 artists-in-residence with a healthy mix of faculty, postdoctoral fellows, grad students, artists, and museum-based professionals. All six of DePOT's core countries are represented in some depth with India (Indranil Chakraborty, Bharat Sundararajan) and China (Wen Xie) also in the mix. We intend to publish an edited volume as well as a special issue of a journal (as yet to be determined), drawing from other contributions to the conference, as well as a monograph on the global politics of deindustrialization authored by Steven High. Five DePOT roundtables are planned over the 2024-25 academic year, culminating in the conference at the CGT union headquarters and Sciences Po in Paris.

In total, the working-group is undertaking eighteen book chapters and journal articles, all of which will be presented at the DePOT conference in Paris in June 2025. Seven of these pieces are transnational or global in reach, with the remainder being national or local cases. Fully half of the chapters/articles are collaboratively written. Thanks to Stefan Moitra, the working-group will integrate first-person interviews with front-line trade unionists in the final volume. The resulting volume and special issue will therefore help us scale-up our analysis

without losing our anchoring in working-class lives. A historiographical paper surveying the field, drafted at the outset, and workshopped within the wider project, was written by James Rhodes and Marion Fontaine. A second historiographical piece -- authored by Myriam Guillemette, Lachlan MacKinnon, Sophia Richter, and Peter Thompson -- considers the relationship between industrialism, colonialism and deindustrialization. Our aim is to also further theorize key concepts with Sherry Lee Linkon organizing a round table to this end. We are confident that our combined efforts will have historiographic punch. - Steven High and Marion Fontaine, Race, Populism and the Left initiative leads.

ENVIRONMENT AND DEINDUSTRIALIZATION

In 2023-2024, the Deindustrialization and the Environment initiative has taken preliminary steps towards achieving several important outcomes. Based on conversations within the working group and discussions at the 2024 DePOT meetings in Glasgow, the initiative has created a draft Table of Contents for a proposed edited collection. Major themes within this proposed collection include toxic legacies, health and the environment, and transitions. Contributors from Canada, the United States, Germany, Italy, and the United Kingdom will produce a series of transnational and comparative chapters that examine these major themes through a variety of case studies. In addition, the initiative is planning for a series of round-table discussions, to be organized online, which will occur beginning in 2025. These will provide an ongoing space of discussion and contemplation for working group members to discuss ongoing research and share ideas and thoughts. While the specific topics have yet to be determined, there will be attention to a variety of topics such as deindustrialization and re-greening initiatives, technological and energy transition, heritage and the environment, and policies of Green Transition. The working group has also explored the possibility of concurrent digital productions that will visualize processes of Deindustrialization and Environmental Change, whether through an ARCGIS mapping project or in conjunction with other digital media projects. While the specifics of this project remain to be confirmed, several working group members have signaled their interest in being involved. Ongoing work within the initiative will be scheduled for presentation at the planned 2027 DePOT meeting in Italy. - Lachlan Mackinnon and Greg Wilson, Environment Initiative Leads

HERITAGE AND/IN DEINDUSTRIALIZATION

The Industrial Heritage initiative chaired by Lucie K. Morisset (Université du Québec à Montréal), Magdalena Novoa (University of Illinois Urbana Champaign), and Stefan Berger (Ruhr University) met during the DePOT annual conference in Glasgow to plan the next two years activities leading to the 2026 annual conference which will be organized around the Industrial Heritage topic. We discussed the content for the edited book we will produce as part of the initiative, the possibility of a special issue in an academic journal, and the importance of involving community organizations in the initiative leading to or during the 2026 conference. The scholarship the initiative aims to produce will center around the question: How can industrial heritage bring relief in deindustrialization processes? What are the main actors that these reliefs and reparations should focus on? If this is not possible, why not? Using a transregional or transnational comparative approach between the different regions of the world involved in the DePOT partnership, the book aims to expand the explanatory and interpretative framework of heritage and/or deindustrialization. The chairs met in August to plan the activities for 2024-2025 and we drafted the call for

chapters that we will circulate in November within the DePOT group. We are also planning the first meeting with DePOT members interested in joining the Heritage Initiative for November 2024, to organize a panel on Industrial Heritage for April 2025 and a session during the 2025 DePot Conference in Paris. - Magdalena Novoa, Heritage and/in Deindustrialization co-leader, with Lucie Morisset and Stefan Berger.

KNOWLEDGE MOBILIZATION

Thanks to DePOT's array of knowledge dissemination strategies, we have reached most of the knowledge mobilization goals that we had outlined in our SSHRC Milestone Report, putting us on track to reach our project's overall goals. We share our research activities through our website (developed by Mat3rial and now available in all four project languages), our X (Twitter) account (1,260 followers), and newsletter (484 subscribers).

The students who have worked as Communications Coordinator are largely responsible for DePOT's increased and diversified digital presence: Philippine D'Halleine (current coordinator), Shaina Willison, Graham Latham, Connor Kilroy, and Amélie Pelletier.

PODCASTING AND MULTIMEDIA CONTENT

The DePOT podcast, initiated by the Student and Postdoc Caucus, has continued to showcase exciting new research with hosts Fred Burrill (Cape Breton University) and William Gillies (Concordia University). One highlight was a DePOT podcast "takeover" by our colleagues at Confronting Decline (CONDE), a deindustrialization research initiative based at the University of Luxembourg.

Aside from the DePOT podcast, DePOT affiliates are also sharing their research on feeds like CBC Sudbury and Radio-Canada Sudbury (Eliot Perrin), *CBC What On Earth* (Petra Dolata), the Alberta Wilderness Association (Anna Bettini), and "Mike Farwell Show," CityNews (Dimitry Anastakis).

DePOT team members have also contributed to various documentary films and series. Jorge Magaz collaborated for the production of a video documentary produced by Laura Martínez Panizo as part of the research project "Queda inaugurado este poblado minero" (This mining company town is now inaugurated), Marion Fontaine contributed to the online exhibition "Expériences ouvrières Vies, corps et luttes" (Workers' Experiences. Lives, bodies and struggles) with the Université of Liège (France), et Genevièvre Lauzière worked on an Exhibition of urbex photography on water heritage as part of the AQPI (Quebec Association for Industrial Heritage). Finally, Guillaume Tremblay-Boily' study on sustainable income outside major centers (Montérégie, Gaspésie-Îles-de-la-Madeleine and Côte-Nord) prompted some thirty interviews in several media (newspapers, radio, TV), including several on the Côte-Nord and in Gaspésie-Îles-de-la-Madeleine.

PUBLIC PROGRAMMING

As a public-facing project dedicated to enriching public discourse on deindustrialization, DePOT and its members have been involved in a variety of public lectures, roundtables, and workshops (see Appendix 4 for a complete list).

2022-2023 ROUNDTABLE SERIES

The DePOT project organized 6 online roundtables in the past year. Each roundtable brought 6-8 people with a range of regional and thematic expertise to speak on a theme. Since the launch of our YouTube channel these roundtables

PUBLIC-FACING WRITING

DePOT's blog, nested on our website, showcases the important research of our students, partners, and research affiliates. In the lead-up to DePOT's June 2024 Glasgow conference on Deindustrialization, Gender, and Family, a symposium was held to discuss Andy Clark's book, *Fighting Deindustrialisation:* Scottish Women's Factory Occupations, 1981-82. This event included three commissioned book reviews from international scholars, Roberta Garruccio, Fred Burrill and Xavier Vigna highlighting DePOT's transnational mission. Finally, the symposium culminated in a response from Andy Clark. Each scholar brought a unique perspective, with reviews touching on various aspects of Clark's work, from gender and labor militancy to international connections.

Beyond the DePOT blog, our affiliates are also sharing their work on Scottish Left Review (Ward), the Raymond Williams Society blog (Vanker), Safe Disposal (Camdzic), and various other institutional and university department blogs.

ARTIST-IN-RESIDENCE PROGRAM

DePOT's Artist-in-Residence program aims to foster creative projects and interventions in the field of deindustrialization studies. Through the program, two grassroots artists per research initiative receive \$8,000 CAD in funding to create and share new work locally and transnationally. This year, the DePOT community met its first two artists-in-residence and is looking forwards to meeting two new artists at our next conference. Thank you to the Artist in Residence committee co-chairs Petra Dolota and Jana Golombek, as well as the other members of the adjudication committee: Emily Gann, Juliette Passilly, and Lisa Taylor.

OUTGOING ARTISTS-IN-RESIDENCE: JENNIFER VANDERPOOL AND JILL MCKNIGHT



Jennifer Vanderpool and Jill McKnight, DePOT's 2023-24 Artists in Residence, presented their work at this year's conference in Glasgow. McKnight's work, "Past and Future Pact," connected us to the lives of the women who worked in Sunderland's Pyrex factory. McKnight's multimedia work, including video, photography, and oral history, broke down barriers between the workplace, the household, and memories of closure. For example, McKnight's overlay of a print of a woman working at the factory, printed onto a Pyrex casserole dish found at a charity shop in Sunderland, brings forward how the residual structures of feeling of industrial work linger in objects.

RAECHELE LOVELL



Raechele Lovell, a passionate Artivist, is rooted on a block of The Haldimand Tract, colonially known as Kitchener, ON Canada. Her journey in the arts began as a child on tour with the polyrhythmic dance and music of her Caribbean heritage, igniting a lifelong quest for creative expression. As a bi-racial artist, with Afro-Caribbean and German Mennonite heritage, Raechele navigates the intricate intersections of identity, culture, and artistry. This rich tapestry of lineage informs her work, intertwining ancestral heritage with contemporary narratives and grounding her in a unique perspective as an Afro-diasporic artist on Turtle Island. Raechele's work is deeply anchored in her decolonial praxis, a framework nurtured through The

Anitafrika Method under the mentorship of d'bi.young anitafrika at the Ubuntu Decolonial Arts Centre. This praxis challenges colonial norms and celebrates the rich traditions of Afrodiasporic storytelling. Raechele believes in the transformative power of the arts as a conduit for healing, understanding, and social justice, driving her commitment to creating spaces where marginalized voices are amplified and stories of resilience and resistance are brought to the forefront. As the Founder and Executive Artistic Director of DiverseWorks Dance Co., Raechele envisions a future where Afrocentric artistry thrives. Her latest project, "Uncovering Roots," delves into the historical and contemporary narratives of deindustrialization, exploring personal and collective resilience through movement. Through her unique artistic voice and vision, Raechele aims to inspire and champion change, inviting audiences on a journey of discovery and healing. Her work is a testament to the enduring power of art to connect, transform, and liberate.

Project statement: Uncovering Roots

Investigating ties to ancestral deindustrialization through artistic practice. In November 2023, I traveled to Barbados for the second time in my life to celebrate my paternal Grandmother's 100th birthday celebration. I used this opportunity to research and investigate my family lineage. Through this research, I uncovered the work of my Great-Uncle Israel Lovell, a prominent Pan-Africanist Activist, and our family's lineage tracing back to slavery on the Drax Hall Plantation. My proposal is to return to Barbados to delve deeper into oral histories and to move my body on the Drax Hall Plantation lands to connect with the spirits of my ancestors and the untold stories they hold. This research will be connected to my place as a bi-racial settler in Canada, a country my father moved to for a "better life" after the borders were opened to countries of colour in the 1960s. On my maternal side, I have three generations of German Mennonite settlers who arrived in the early 20th century in then Berlin, Ontario—my hometown of Kitchener, ON. Throughout my life, I have faced marginalization and a lack of

place within this society, struggling with housing precocity, food insecurity, access to education, and numerous other social issues resulting from systemic and institutional racism. My aim is to explore my position within the landscape of Canadian culture as a biracial artist settler and to examine how these experiences intersect with deindustrialization in the British Commonwealth.



PAUL TOM For the last 12 years, Paul Tom has been drawing on the intimate to tell life stories with sensitivity. His films give a voice to those who are not always heard, creating dialogue and opening our arms to others. Born in a refugee camp in Thailand, his favourite themes to explore are the construction of identity, family relationships, and everything that touches on the fragile side of being human. His films Seuls and Bagages have been selected for some forty film festivals around the world, winning a dozen awards. He is also the author of the young adult graphic novel Seuls, published by la courte échelle.



REMY CHHEM, co-founder of the Super Boat Collective, is a longtime community organizer, particularly within the Cambodian community. Having been previously involved in the Montreal Life Stories project and the Centre Khémara, he is now focused on creating dynamic projects that foster bridges, collaborations, and dialogue between communities and generations. Within the Super Boat People, Rémy leads various projects related to community and family history in addition to culinary and horticultural knowledge. Outside of the collective, Rémy works as an academic researcher in the social sciences, specialising in political ecology and with a marked interest in history and envrionmental justice.

The Capstone Exhibit is the culmination of DePOT's work. In the SSHRC grant, the Capstone Exhibit is described as the ultimate public-facing output of the project, as a multisited travelling exhibition, bringing together stories and artifacts across the partner countries. The Exhibit is scheduled to take place in the final year of the project, now 2028. At this year's Project Assembly in Glasgow, Capstone Exhibit committee leads Rebecca Dolgoy and Jana Golumbek, consulted DePOT affiliates as to the best way to execute the project. Following this meeting, Dolgoy, Golumbek, along with DePOT staff Gab McLaren and Liam Devitt, developed the final plan and budget for the Capstone Exhibit. This plan was approved by the Coordinating Committee.

The Capstone Exhibit will consist of 6 "story panels" created by a DePOT Project Curator (MA or PhD student affiliate) in collaboration with a graphic designer and a liaison from each of the thematic initiatives. The story panels will highlight the oral history work that is so key to the research of many DePOT affiliates. Each initiative has a designated budget to fund the mounting of the story panel at an appropriate community space, like a union hall, community centre, educational institution or local museum, along with a small linked event, like a vernissage, symposium, roundtable, or talk. Each story panel will have a linked postcard, which shows an artistic interpretation of the themes shown in the story panel. The artwork on the postcards will be commissioned by DePOT. We will prioritise artists that have connections to deindustrialized communities.

2024 SUMMER INSTITUTE RECAP BY LAURA LITTLEFAIR

This year, the DePOT Summer Institute took students and postdoctoral affiliates to Belfast in Northern Ireland, from 20th - 22nd June. We were hosted in The Graduate School at Queen's University, which opened as the Lynn Library building, part of Queen's College Belfast in 1868. The building is a vibrant postgraduate activity, and it was the perfect location for this year's Summer Institute, packed with two days of exciting papers, posters, and panels.

The theme this year was 'Difficult Histories of Gender and Community,' tying into the theme of the conference

centring on Gender and Family. Proceedings began with a roundtable addressing recent work on the cultural and social history of Northern Ireland, led by Sean O'Connell, Professor of History at Queen's University. The roundtable introduced students to the history of Belfast, and Northern Ireland more generally, including the history of the Troubles, and the active

research going on that gives voice to, and readdresses, this difficult but integral part of Northern Irish History.

Over the next two days there were 6 panels, each with 2-4 papers from DePOT students and postdoctoral affiliates. as well as external researchers that work on deindustrialisation. A full programme of all who presented their work can be found on the DéPOT website. The panels addressed deindustrialisation in many varied but symbiotic forms, including troubling masculinities. intergenerational legacies, the lens of childhood, the state and politics, urban places, and expressions of loss. We also had the pleasure of two workshops, with the first allowing participants to engage with inclusive heritage practices with postdoctoral

affiliate Guilherme Pozzer and one of DéPOT's 2023-2024 artists-inresidence, Jennifer Vanderpool The DePOT's care for its affiliates has also allowed the travel and participation fees for these academic events to be covered by the project, for which I am very grateful. In addition, the DePOT website, as an archive, enables networking with colleagues, as well as Basecamp and its respective work tools. I consider this, in parallel to the annual face-to-face team meeting, to be very positive for my training as a doctoral student and researcher.

second workshop was facilitated by Sophia Richter, looking at research methods and methodological approaches to studying deindustrialisation, and how as deindustrialisation scholars we can use these in our own work. The two days concluded with a roundtable discussion about why we choose to study deindustrialisation. This was moderated by Steven High, featuring two presentations on the histories of capitalism, class, and their relationship to deindustrialisation as a field of research, followed by questions and comments from Fred Burrill and the wider Summer Institute cohort.

Following the Summer Institute, on the morning of 22nd June, the annual in-person Student Caucus meeting was held with existing DéPOT students and postgraduate affiliates, to discuss the past year of online talks and activities, as well as plans for the year ahead. At this meeting the current Student Caucus Steering Committee stepped down from their positions, and thanks must go to Naomi Petropoulos, Rebekah Chatellier, Sinead Burns, Shonagh Joice, and Katherine Watson, for all of their hard work on the committee. The incoming Steering Committee were chosen during this meeting, which includes Graham Latham, Adna Camdzic, and Laura Littlefair. Similarly, the student representative for the DePOT Coordinating Committee stepped down, and thanks must also go to Tom Wilson for his role over the past 2 years, with the new student representative being Seana Irvine. Huge thanks and appreciation must also go to the organising committee of the Summer Institute, for arranging and hosting an excellent few days in Belfast: Sinead Burns, Shonagh Joice, Naomi Petropoulos, Adna Camdzic, and Sean O'Connell.

As well as academic pursuits, the Summer Institute was an opportunity to catch up with friends and scholars from across the world, whilst also making new connections with DePOT affiliates who have recently joined the organisation. A perfect way to do this was at the Summer Institute meal at The Jharna, where we were all treated to a meal courtesy of DePOT and Queen's University. On the afternoon of 22nd June, following the Student Caucus meeting, there was the chance to explore Belfast on walking tours to either the Titanic Quarter with Pete Hodson, or Sailortown with Sean O'Connell. Both tours offered the opportunity to learn about the rich history of shipbuilding and dockwork in Belfast, explore some of the vast collection of murals, and understand more about the legacy of the Troubles around the city. On 23rd June, the Summer Institute cohort travelled to Glasgow via the Belfast to Cairnryan ferry, ahead of the DePOT Project Assembly and Conference the following week. It's safe to say we all had a wonderful time at the largest Summer Institute yet, and as a first-time attendee to the DePOT Summer Institute and Conference, I felt incredibly welcome and truly a part of the deindustrialisation studies community!

2024 ANNUAL CONFERENCE: GENDER, FAMILY, AND DEINDUSTRIALIZATION

This June, scholars of deindustrialization gathered in one of Britain's great industrial cities to discuss how gender and families have affected and were affected by histories of deindustrialization. The conference, "Gender, Family and and Deindustrialization" was hosted from June 24-26 at the University of Glasgow and the University of Strathclyde, and was organized by Jackie Clarke, Arthur McIvor, Yvonne McFadden, Rebekah Chatellier and Piyusha Chatterjee.

On June 24, we held the annual DePOT Project Assembly, where project members celebrated new accomplishments, updated each other on their new work, and planned for the years to come. Of note, the Heritage and Environment initiatives met, and began to carve out their plans for the years to come. That night, Arthur McIvor, Ewan Gibbs, and Yvonne McFadden held walking and museum tours, taking conference goers through histories of shipbuilding, energy transitions, and cultural interpretations of deindustrialization.

The conference was two days of brilliant discussion, with 115 attendees, 53 papers delivered, and two marvelous keynotes. Florence Sutcliffe-Braithwaite and Natalie Thomlinson reflected on how gender and deindustrialization affected political subjectivities in Britain. Fanny Gallot took us through how reproductive labour has—and has not—been represented in historiographies of deindustrialization in France. In addition, DePOT artists-in-

residence Jennifer Vanderpool and Jill McKnight showed us how DePOT help progress their work.

We are particularly grateful to Glasgow City Council for hosting us in their magnificent city chambers for a reception and celebration of DePOT members newly published works.

The closing plenary session, with Lauren Laframboise, Jackie Clarke, Piyusha Chatterjee, and Petra Dolata allowed us to think synthetically about all of the papers of the last two days, and chart new directions for research to follow in the project's remaining years.

QUEER HISTORIES OF INDUSTRIAL WORK: A DEPOT AND INGENIUM COLLABORATION

Starting last year, work began on the Queer Histories of Industrial Work project, a collaboration between Ingenium and DePOT looking to uncover and historizice the relationships between queer communities and industrial work. The ultimate outcome of the project is to inform Ingenium's exhibits and bring queer perspectives into histories of industrial work, in particular histories of the rail industry. Liam Devitt, now the DePOT Associate Director, served as the first researcher on this project, working with Emily Gann at Ingenium. This year, the project focused on laying the groundwork for further primary source research, performing scans of relevant archives, similar museum initiatives, and literature reviews. A new researcher will be hired on this Fall to continue this work, focusing on archival research at ExpoRail in Saint-Constant QC.

BUDGETS & FINANCES

DePOT has continued to spend wisely within the project's budget envelopes, following the budget established by the Coordinating Committee in November 2020.

UNDERSTANDING THE TABLES BELOW

The tables below show the actual expenses from the first four years of the project and the projected expenses for the following years of the project, as reported to SSHRC. The budget categories are those used by SSHRC, repeated here for consistency and ease of reporting. As in past years, DePOT's main expenses have been student and postdoc funding, in addition to the full-time project director's salary (see: "Non-student salaries and benefits/stipends—Other" category). Also note that the "Professional/Technical Services" category, which has seen significant jumps, is largely related to translation services, web development, and the artist-in-residence program. Note that these tables only denote the use of funds from DePOT's SSHRC Partnership Grant.

The table does not reflect or include the funds contributed by DePOT's partners or additional funding received by the project, including: Canada Summer Jobs Program wage subsidies for student workers, a Canadian Foundation for Innovation grant, and the SSHRC Insight grant that funded the 2023 Cape Breton Conference. This is especially noteworthy as far as student fellowships are concerned, as half of fellowships are paid through DePOT SSHRC funds, with the other half coming from the receiving student's home institution).


