# MESSAGE FROM THE PRINCIPAL INVESTIGATOR, STEVEN HIGH

#### THE YEAR IN REVIEW

The DéPOT project completed its fifth year in April 2025. There are just three years remaining, including our wind-up year.

The year began last June with a very successful conference on Gender, Family and Deindustrialization in Glasgow, Scotland, which brought together over one-hundred researchers on a dimension that has been largely overlooked in the field. The conference will be remembered as a historiographical milestone as a result. The Summer Institute, held just prior in Belfast, was probably the most inspiring to date. Huge thanks to the organizers of both highly successful events.

The project continued to organize virtual round-tables during the academic year, which are now available on our YouTube channel. Two roundtables showcased the work of some of our newest members. A highlight was the roundtable marking the retirement of Tim Strangleman, who has had a significant influence on deindustrialization studies.

We published eight research blogs over the year that considered a variety of issues including deindustrialization as people's history (Gilda Zazzara), the memoirs of women in Polish mining families (Monika Glosowitz), "Dole Songs and Coal Songs" in England (Keith Gildart), the Alto Cielo Archaeological Project in Chile (Francisco Rivera), and the decline of American fisheries (Sophia Richter).

Three of our affiliated students successfully defended their PhD dissertations in the past year: Dr. Théo Georget (Université de Lorraine), Dr. Amber Ward (University of St. Andrews), and Dr. Jorge Magaz-Molina (University of Alcala). William Gillies (Concordia University) received his Master's. Congratulations all! We look forward to your future books!!

Speaking of books, the past year saw the publication of the first edited volume coming largely out of the project. The *Routledge International Handbook on Deindustrialization Studies* was co-edited by Tim Strangleman, Sherry Lee Linkon, Steven High, Jackie Clarke, and Stefan Berger. It includes a number of other DePOT contributors such as Andrew Perchard, James Rhodes, Fred Burrill, Matthew Penney, Lachlan Mackinnon, Marion Fontaine, Xavier Vigna, Alice Mah, Liam Devitt, Helen Wagner, Peter Thompson, and Piyusha Chatterjee.

Several monographs appeared this year including those from Leo Grob, Lisa Taylor, Tom Fraser, and myself.

We continued to fund student-led initiatives which has provided vital support to our many affiliated students and postdocs. For the first time, we also funded seven projects from our new DePOT Trade Union Fund. The goal of the funding is to cement the project's partnership with the trade union movement, thereby ensuring our research is responding to their priorities in research as well. To give just one example, le Centre d'histoire et archives du travail received funding to support union-led research on deindustrialization in five Quebec communities.

The project's coordinating committee has a new member – Sherry Lee Linkon, who replaced Tim Strangleman as co-lead (with Jackie Clarke) of the Working Class Expression working group after Tim retired. Jana Golombek and Petra Dolata continue to do their usual magic in coordinating our Artist-in-Residency program. The same is true of the exhibition and deindustrial objects committee, led by Rebecca Dolgoy and Jana Golombek. A new teaching committee was formed this year led by Hilary Orange and Sherry Lee Linkon, which is an important new development for the project as a whole.

All the working groups are busy with their research and writing. As we move into the final three years of the project, the number of working-groups continues to decline from this point on.

We continued to welcome new affiliated members, including two new full co-researchers Yuan Yi (Concordia) and Fred Burrill (University of New Brunswick). Almost all apply after participating in our conferences or attending our online round-tables.

#### FAST FACTS AND WORKING GROUP REPORTS

#### Governance and Ethics

DePOT continues to be governed through a collective governance structure, anchored by our Coordinating Committee (see Appendix 1). In summer of 2024, Liam Devitt took on the role of Associate Director and continues in that role now.

The project's Coordinating Committee continues to meet bimonthly to approve new affiliations on an ongoing basis to expand the project, keeps a bird's eye view of the project's activities, and ensures that DePOT adapts to new developments while still fulfilling the goals and obligations originally established in our application.

Besides the Coordinating Committee, DePOT has three project-wide administrative committees responsible for (1) the artist-in-residency (AIR) programme (co-led by Jana Golombek and Petra Dolata), and (2) the Curatorial Committee, handling both the "Histories of Deindustrialization through Objects" platform and our Capstone exhibit, and (3) a teaching committee led by Sherry Lee Linkon and Hilary Orange . There is also an active self-governing student and postdoc caucus.

DePOT retains full ethics approval from Concordia University, from which the project-wide ethics framework for oral history interviewing follows. As the funding comes from Canada, the entire project must follow Canada's <u>Tri-Council Policy on Research Ethics</u>. Project affiliates may access documents related to our ethics through Basecamp. In cases where there are no formal research ethics regimes (Italy, France, Germany) or where oral history is exempted from institutional review (United States), DePOT members use the Concordia model.

The thematic working groups, where the bulk of research is undertaken, are each co-led by two co-investigators. Our annual Project Assembly offers a space of project-wide reflection.

#### Student & Postdoc Caucus Report

The Student Caucus is an informal peer group of affiliates and is intended to foster dialogue, connection and shared learning. In the 2024-25 school year, the Caucus was facilitated by four student affiliates representing three countries: Canada, the UK and Italy. The Caucus met on the third Thursday of the month. In total, 6 sessions were held between October 2024 and April 2025.

To help identify conversations of most interest, the coordinating committee kicked off in the fall 2024 term with a questionnaire and to encourage student participants to suggest an activity that they would like to coordinate. The Coordinating Committee followed this up with a poll highlighting topics of most relevance. These ranged from how deindustrialization is represented in popular culture, to peer review works in progress, cross-disciplinary research approaches and publishing tips and techniques. Some of the hosted topics included:

- Contributing to the Community: addressing questions such as 'How do people use
  their research practically to help the community?" Participants brought an example of
  another scholar's engagement with their community that they found inspiring. This
  was followed by a presentation on community engagement by a student scholar
  working on a railway museum initiative in the UK.
- Going public: Dr. Steven High discussed strategies for engaging with media and
  "going public" with our research outside the bounds of academia. This topic was of
  particular relevance given the shifting geo-political environment and helped students
  contextualize the deep relevance of deindustrialization research to current events the
  world over.
- Welcoming DePOT Artist-in-residence: The group had the chance to hear from Raechele Lovell and her co-collaborator and director Lisa Karen Cox for a discussion on art and deindustrialization. Raechele's work engages with decolonial artistic practices to envision more just and equitable futures, with a particular focus on Afrodiasporic storytelling.

The Caucus also served as a sounding board for discussing the annual Summer Institute and discuss potential roundtables, workshops, or other collaborative activities.

Participant attendance averaged between 8 and 10 students per session. In addition to crowd sourcing topics for discussion, to support participation the coordinating committee also adjusted session times to make it as easy as possible for people from multiple time zones to participate.

#### Politics of Industrial Closure

The Industrial Closure Working Group has officially finished its work, with the volume *The Politics of Industrial Closure scheduled* to be published in March 2026. The volume features thirteen collaboratively written chapters, all of which cross borders. The working group had earlier published special issues of *Labor History* and *Labour/le Travail* as well as *Our Times*.

#### Gender, Family, and Deindustrialization

The Gender initiative's work is also almost finished, with the volume about to be sent to peer review, following the successful conference in Glasgow last year.

### Race, Populism & the Left

The group's activities focused on preparing and organising an international conference on this topic (conference entitled 'Deindustrialisation, Nation, Immigration: What Policy Responses?', Paris, 19-21 June 2025). The conference was well attended and contributed to the dissemination of research on deindustrialisation to the French-speaking public. We held a series of virtual round tables on this theme in autumn 2024 and spring 2025,

exploring key concepts of the initiative, like settler colonialism, race and caste, populism, and left-wing responses to deindustrialization. All were well attended and brilliantly showcased the work of DePOT members, in particular the work of emerging scholars.

Several publications are expected to result from the work and discussions related to this conference: a book in preparation edited by Steven High and Marion Fontaine, Race, Populism and the Left (manuscript due in early summer 2026); a special issue of a journal (edited by James Rhodes, Amber Ward and Marion Fontaine) which has been submitted to the journal Ethnic and Racial Studies.

#### Environment and Deindustrialization

In 2023-2024, the Deindustrialization and the Environment initiative has taken preliminary steps towards achieving several important outcomes. Based on conversations within the working group and discussions at the 2024 DEPOT meetings in Glasgow, the initiative has created a draft Table of Contents for a proposed edited collection. Major themes within this proposed collection include toxic legacies, health and the environment, and transitions. Contributors from Canada, the United States, Germany, Italy, and the United Kingdom will produce a series of transnational and comparative chapters that examine these major themes through a variety of case studies. In addition, the initiative is planning for a series of round-table discussions, to be organized online, which will occur beginning in 2025. These will provide an ongoing space of discussion and contemplation for working group members to discuss ongoing research and share ideas and thoughts. While the specific topics have yet to be determined, there will be attention to a variety of topics such as deindustrialization and re-greening initiatives, technological and energy transition, heritage and the environment, and policies of Green Transition. The working group has also explored the possibility of concurrent digital productions that will visualize processes of Deindustrialization and Environmental Change, whether through an ARCGIS mapping project or in conjunction with other digital media projects. While the specifics of this project remain to be confirmed, several working group members have signaled their interest in being involved. Ongoing work within the initiative will be scheduled for presentation at the planned 2027 DEPOT meeting in Italy.

#### Heritage and/in Deindustrialization

This year, the Heritage and (De)industrialization initiative chaired by Lucie K. Morisset (Université du Québec à Montréal), Magdalena Novoa (University of Illinois Urbana Champaign), and Stefan Berger (Ruhr University) have focused its work mainly on starting the process of the edited volume that we will produce as part of DePot. The chairs have met regularly over the year, launched the call for papers and selected the 21 abstracts that will contribute to the book. The volume will center around the question: Can industrial heritage bring relief in deindustrialization processes, and if so, how and to whom? If not, why not? Using transregional or transnational comparative approach between the book aims to expand the explanatory and interpretative framework of heritage and/or deindustrialization. Therefore, the chapters will not center on singular case studies but in producing a critical and analytical around heritage and (de)industrialization between different geographies. On October 15th, 2025, we held our first working group meeting with the selected authors and discussed the rationale of the book. Based on the submissions, the chairs clustered authors working on similar topics to encourage them to collaborate in writing chapters. The next steps include defining the authors that will collaborate for the book and organize two online roundtables for 2026.

#### Working-Class Expression

The Working-Class Expressions group held an initial meeting in September and has begun discussions of key questions it wants to address, options for the work the group will produce, and how we might contribute to the final DePOT exhibition. The group brings together scholars from a range of disciplines including literary studies, history, anthropology and sociology, and has recently expanded with 9 new affiliates. Our aspiration is produce a digital collection of working-class expression that brings texts and other forms of expression into a transnational dialogue. To this end, we are currently consulting with colleagues within DePOT and in our institutions for advice on how to develop a useful, sustainable, and meaningful digital project. We are also assembling a steering committee, hoping to draw on the experience, expertise, and interests of those who have created digital collections and exhibits as we plan our work. Our next meeting will invite participants to address the question 'what is working-class expression?' and will provide an opportunity for researchers from different disciplines and academic cultures to develop a shared understanding of this category.

#### **KNOWLEDGE MOBILIZATION**

Thanks to DePOT's array of knowledge dissemination strategies, we have already reached most of the knowledge mobilization goals that we had outlined in our SSHRC Milestone

The affiliation with DePOT is critical to helping think about deindustrialization in a more overarching and comparative way that highlights both the parallels and differences across geographic regions - forcing us to ask and understand why in both instances. Report in previous project years, putting us on track to reach our project's overall goals. We share our research activities through our website (developed by Mat3rial and now available in all four project languages), our Bluesky account (545 followers) and newsletter (654 subscribers, up from 484 last year). We made the decision to delete our X account and migrate wholly to Bluesky given the climate on that platform and the incongruity between the values of the platform's owner and the values of our project.

The students who have worked as Communications Coordinator are largely responsible for DePOT's increased and diversified digital presence: Théa Bashore (current coordinator), Philippine D'Halleine, Shaina Willison, Graham Latham, Connor Kilroy, and Amélie Pelletier.

#### Podcasting and Multimedia Content

The DePOT podcast, initiated by the Student and Postdoc Caucus, continues to be maintained and will showcase the work of DePOT affiliates on an irregular basis. The English-language host is William Gillies, and the French-language host is Fred Burrill, with other DePOT members open to fill in. For example, this June, Adna Camdzic interviewed cultural geographer Leila Downey on her work on nuclear plant closure in Lithuania.

DePOT continues to be my academic home and the focus of most of my intellectual energy. I taught a class on "Deindustrialization in North America" in Winter 2025; students were lucky enough to have the vast resources and reflections of the partnership available to them, and really benefitted from it. - Fred Burrill

#### Public Programming

As a public-facing project dedicated to enriching public discourse on deindustrialization, DePOT and its members have been involved in a variety of public lectures, roundtables, and workshops. These can all be seen in the Bibliography.

DePOT's online roundtables keep up our public engagement as a project, providing space for us to both workshop new ideas and translate them to a wider audience. This year's roundtables, linked with the Race, Populism and the Left initiative, were a great success, attracting a strong and consistent turnout, trending upwards. Of particular note is February 2025's roundtable, a conversation honouring the contributions of DePOT member Tim Strangleman as he heads into retirement.

#### Artist-in-Residence Program

DePOT's Artist-in-Residence program aims to foster creative projects and interventions in the field of deindustrialization studies. Through the program, two grassroots artists per research initiative receive \$8,000 CAD in funding to create and share new work locally and transnationally.

# OUTGOING ARTISTS-IN-RESIDENCE: RÉMY CHHEM, PAUL TOM AND RAECHELE LOVELL

This year, DePOT was proud to welcome three artists in residence working on projects that explore the linkage between race, racialization and deindustrialization.

Rémy Chhem and Paul Tom's project "Mémoires en filiature", is a graphic novel with multimedia elements that tells the story of Tom's mother, a Cambodian immigrant to Montreal, who did garment piece-work in her home. At the conference in Paris this June, we were shown a short video tying together Tom's illustrations and a beautiful voiceover, all anchored in Chhem's diligent research into the Montreal garment industry.

Raechele Lovell, with her collaborator Lisa Karen Cox, performed "Uncovering Roots",a performance piece that engages with Lovell's personal and family history, and how that history can be operationalized by whiteness to its own ends. Lovell invited us to think about our own positionality and how race and whiteness in particular exists within our research and the way we do our research.

The Artist-in-Residence selection process has been delayed, due to the change in theming for the 2026-27 year from Heritage to Environment, the recruitment process is currently ongoing.

End of project Capstone Exhibit: Deindustrial Solidarities

Work on DePOT's Capstone Exhibit has continued apace. The Curatorial Committee, lead by Rebecca Dolgoy and Jana Golombek, continue to steward this project and the Histories of Deindustrialization Through Objects website. In the SSHRC grant, the Capstone Exhibit is described as the ultimate public-facing output of the project, as a multisited exhibition, bringing together stories and artifacts across the partner countries. DePOT has rehired Philippine d'Halleine, previously Research Support Officer, on as our new Exhibit Curator. The exhibit's tentative theme is "Deindustrial Solidarities." The intention behind this theming is to illustrate how deindustrialization is a global process, and that the effects of plant closure and capital flight can be traced across the globe, and that in knowing that we can build new solidarities among working-class communities. The Capstone Exhibit will consist of 6 "story panels" designed by the Curator, in collaboration with a graphic designer and a liaison from each of the thematic initiatives. Each initiative has a designated budget to fund the mounting of the story panel at an appropriate community space, like a union hall, community centre, educational institution or local museum, along with a small, linked event, like a vernissage, symposium, roundtable, or talk. Each story panel will have a linked postcard, which shows an artistic interpretation of the themes shown in the story panel. The artwork on the postcards will be commissioned by DePOT. We will prioritise artists that have connections to deindustrialized communities.

#### 2025 Summer Institute

For this year's summer institute, DePOT went to the famous Lorraine region of France, one of the most notable coal and steel regions in Europe. We were graciously hosted in Nancy at the Université de Lorraine by local organizers lead by Prof. Pascal Raggi, Pierre Toussenot and Théo Georget. The programming of the summer institute was undertaken by a student-run committee of Théo Georget, Myriam Guillemette and Juliette Passilly, with help from Associate Director Liam Devitt. On the first day, we travelled to Longwy, a

former steel town to the north of Nancy, close to the Belgian and Luxembourgish borders, with our first day taking place largely at the council chambers of DePOT partner, the Agglomeration of Grand Longwy, who facilitated site visits to a community labour archive, and various sites that were once part of the Senelle-Maubeuge steel plant. On the second day, we heard from DePOT students and emerging scholars at the Université de Lorraine. Like in previous years, participatory workshops were a hit, including one covering self-reflexivity, another on creative

methods, and one on the role of the State in deindustrialization. For the first time, DePOT was offer concurrent French/English able translation for a summer institute. This was doubly important considering this is the first conference taking place in a region that speaks French language, one of DePOT's working languages. Despite this status. English predominates in the project, like it does in academia globally. DePOT thanks the students at the Université de Lorraine who worked as interpreters, they provided a crucial service that increased understanding and broke down barriers.

As has been the case since the beginning, affiliation with DePOT contributed foundation's to the activities with suggestions for improving our public engagement, indications of research avenues, bibliographic updates and updates on sources and documents. - Fondazione ISEC: Giorgio Bigatti and Roberta Garruccio

This June, we held our fourth annual conference, titled: "Deindustrialization, nation, immigration: What political responses?" This conference was the outcome of the Race, Populism and the Left thematic initiative, co-lead by Marion Fontaine and Steven High. This conference sought to bridge the gap between discussions of populism and migration, and that of the lingering effects of deindustrialization. The organizing committee of Marion Fontaine, Marion Henry, Xavier Vigna and Pascal Raggi curated a wonderful program, where we

heard from scholars working in a variety of context, notably those in the trade union movement. A highlight of the conference was our Project Assembly at the headquarters of the Conféderation générale de travail (CGT), one of France's largest trade union centrals. At the CGT's monumental headquarters in Montreuil, we heard from trade union leaders about

how they are responding the the aftereffects of plant closure, imminent risks of deindustrialization in certain industries, and how to build back industry and the labour movement. We had two exceptional keynotes: Alessandro Portelli and Nicolas Verscheuren. Portelli, the doyen of oral history research, told us the story of the shifting political culture of his hometown in Italy. Verscheuren explored representations of deindustrialization in comic books and graphic novels. DePOT heartily thanks both keynotes for their wonderful presentations.

#### Publications

#### DePOT Trade Union Fund

One of DePOT's key objectives as a research project is to build strong research links with the labour movement. In support of this objective, DePOT created a new Trade Union Research and Diffusion Fund with an initial budget of \$30,000, dedicated to supporting research for, by and with trade unions. The response to the first round of applications in Fall 2024 was incredibly strong that we will continue this program in future years.

- Andy Perchard and Keith Gildart, for their collaboration with the GFTU and NUM, developing union education materials on the history of coal communities in Britain (\$3595)
- Stefan Backius, to fund research on deindustrialization's effects on trade unionism in Bergslagen, Sweden, with outputs to be published in the trade union press (\$1655)
- Steven High and Dimitry Anastakis, for their collaboration with Unifor, researching worker adjustment centres as a method of mitigating the effects of plant closure, (\$5000)

#### **BUDGETS & FINANCES**

DePOT has continued to spend wisely within the project's budget envelopes, following the budget established by the Coordinating Committee in November 2020.

#### Understanding the Tables Below

The tables below show the actual expenses from the first four years of the project and the projected expenses for the following years of the project, as reported to SSHRC. The budget categories are those used by SSHRC, repeated here for consistency and ease of reporting. As in past years, DePOT's main expenses have been student and postdoc funding, in addition to the full-time project director's salary (see: "Non-student salaries and benefits/stipends—Other" category). Also note that the "Professional/Technical Services" category, which has seen significant jumps, is largely related to translation services, web development, and the artist-in-residence program. Note that these tables only denote the use of funds from DePOT's SSHRC Partnership Grant.

The table does not reflect or include the funds contributed by DePOT's partners or additional funding received by the project, including: Canada Summer Jobs Program wage subsidies for student workers, a Canadian Foundation for Innovation grant, and the SSHRC Insight grant that funded the 2023 Cape Breton Conference. This is especially noteworthy as far as student fellowships are concerned, as half of fellowships are paid through DePOT SSHRC funds, with the other half coming from the receiving student's home institution).


